BMC Voting at AGM

If you are over 18 years of age and a current member of the BMC you are entitled to one vote per agenda item at the BMC AGM.

If you attend the AGM in person your one vote is counted by a show of hands.

If you are unable to attend the AGM in person, you can nominate a **Proxy** to cast your vote on your behalf.

Proxy Voting

To allow another BMC member to vote on your behalf at the AGM you must complete this proxy voting form in full.

The proxy voting form must be received by the BMC office 48 hours prior to the AGM for it to be valid.

The proxy voting form must be signed for it to be valid. Indicate your direction of vote by marking the relevant box with a cross.

Your Nominated Proxy must attend the AGM in person to allow your vote to be counted.

If you do not stipulate the direction of your vote, then your Nominated Proxy can use your vote as they see fit.
